# Transforming EU market surveillance and removing unsafe products from the European market

It is with great pleasure that <u>PROSAFE</u> announces the launch of the Joint Action on Harmonised Products - <u>JAHARP2021 Omnibus</u>.

The JAHARP2021 Omnibus is co-funded by the European Union and is formed by ten autonomous yet synergetic market surveillance Joint Actions each with a duration of 24 months.

In total, 45 Market Surveillance Authorities (MSAs) from the 25 following countries participate: Belgium, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Finland, France, Germany, Greece, Iceland, Ireland, Italy, Latvia, Luxembourg, the Netherlands, Norway, Poland, Portugal, Romania, Slovenia, Spain, Sweden, and Switzerland.


We continue working on market surveillance from consolidating achievements made so far in energy efficiency, ecodesign, radio equipment, low voltage, and machinery, to engaging in product areas where no joint EU market surveillance action took place yet, such as the automotive and marine equipment sectors."

# The JAHARP2021 activities

Laboratory testing, online and visual inspections, training and capacity-building elements, enforcement, next to the formulating evidence-based policy feedback are combined to give a 360° market surveillance process. The targeted products and the activities of the JAHARP2021 Omnibus are:

- TV monitors and displays. Kick-off meeting on 23/06/2022.
- Aftermarket non-original brake components. Kick-off meeting on 31/05/22.
- Scissor platform lifts.
- Radio equipment WLAN 5GHz.
- Radio equipment in cars.
- Circular saws.
